International Bromont equestrian competitions are sanctioned Gold by Equestrian Canada, 2451 RIVERSIDE DRIVE, OTTAWA, ONTARIO, K1H 7X7, and are governed by Equestrian Canada rules. (A602.1)

Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book. (A602.2)

PARTICIPANTS' OBLIGATIONS:

a) All athletes, owners, and persons responsible must be members of their respective country's National Federation. All owners and athletes must hold a current EC Sport Licence Gold, Platinum (FEI) or the equivalent US Equestrian membership.

b) All athletes competing in amateur classes must have a valid EC Amateur Card.

c) Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC, and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. (A602.7) Do not participate in this EC- sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition.

d) Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location." (A602.5)

e) All horse entered in any class at a competition must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations." (A602.8)

f) When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries, must be in good standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environment.

COGGINS TEST & VACCINES

Proof of vaccines within 6 months of administration of EHV 1 & 4 and Equine Influenza as per Article A519.

Coggins test must be dated within 12 months.

GROUND FEE / SHIP-IN

A ground fee of 75\$ will be charged for ship in horses or horses without a stall at the show.

METHOD OF PAYMENT

A payment covering admin fees will be charged for each horse when registering. Moreover, at the time of the entry on Show Management System, participants will be asked to submit a valid credit card number to cover other fees and expenses incurred during the competition. All accounts should be settled at the end of each week before the participants departure. All unpaid balances will be settled with the credit card on file by the office and an admin fee of 25\$ will be charged. Interac payments will not be accepted.

No bills will be modified after the event. For all questions or corrections, you must go to the show office before the end of the show.

The Bromont International wishes to support Canadian athletes in show jumping. A voluntary \$10 fee for Can Jump is automatically added to each entry. Exhibitors who do not wish to contribute may opt out by notifying the Show Secretary prior to the close of the competition.

DECLINED PAYMENT

A 50\$ penalty fee will be charged for all declined credit cards.

ENTRIES

No entry is accepted without the signature of the person responsible. For a minor participant, the signature of the parents or legal guardians is required to validate the entry. No entry is accepted over the phone. Entries must be received solely on Show Managements System no later than July 7, 2026.

All athletes competing in amateur classes must possess a valid EC amateur card and must present it to the competition secretary upon request (A902).

Pony/horse measurements to be scheduled with the show office.

NOMINATION FEE

All horses registered in jumper classes must pay a nomination fee of 150\$. No nomination fee will be charged to horses registered in the following classes: Young Horses 5, 6, 7 yrs old, François Ferland Medal, CET Medal, JR-AM 0.80m, 0.90m, 1.0m & 1.10m.

NON-SHOWING HORSE FEE

Non-showing horses are given a show number that they must always wear. They are also subject to all EC rules and show grounds rules. A 100\$ fee per horse will be charged.

LATE STALL RESERVATIONS

Late stall reservations and late entries may be accepted depending on stall availability and with the Organizing Committee's approval, without prejudice.

A 50\$ late fee will be added to all stall reservations received between June 17 to July 20, 2026.

A 100\$ very late fee will be added to all entries received after July 20, 2026.

LATE ENTRIES

A 50\$ late fee will be added to all stall reservations received between July 9 to July 20, 2026.

A 100\$ very late fee will be added to all entries received after July 20, 2026.

REFUSED ENTRY

The Organizing Committee has the right to refuse any rider or registration if they do not conform to the rules of the show or to the Equestrian Canada Code of Conduct and Ethics.

REGISTRATION CANCELLATIONS

No reimbursement of admin fees will be issued after the closing dates of entries.

ARRIVAL & DEPARTURES

Unless prearranged with the Organizing Committee, horses must leave the site before 8pm on Sunday.

OFFICE HOURS & DECLARATIONS

On competition days, the office will open at 7am and close at 4pm. It will also stay open from 9am to 4pm on Tuesday preceding the show weeks. Declarations for the following day will close at 4pm every evening and must be done through www.showmanagementsystem.ca

REGISTRATION CHANGES AND ADDITIONS

All adds and scratches must be done online only. No other method will be considered.

All classes must be registered in the system before 4pm the previous day of the competition.

If permitted by management, same day adds will be charged an additional fee of 10\$.

An extra 25\$ fee will be charged to competitors for any horse ridden in a class without being officially registered. This fee is charged on top of the class fee.

Any participant who does not show up for a class where he is officially registered, without cancelling as indicated above, will be charged for the class.

Substitution of horse/entries will be at the discretion of the organizing committee.

PROGRAM CHANGE

The organizing committee reserves the right to cancel or combine classes, change their order on the schedule, change the terms of the competition or refuse any entry, as deemed necessary.

Expected start times for classes will be updated every evening for the following day. All competitors should refer to Show Management System for the "How many" and classes that are with posted orders.

The organizing committee reserves the right to accept or refuse any hors concours or same day adds if the schedule doesn't permit.

The organizing committee reserves the right to cancel all open card schooling classes if there are too many entries on certain days.

PRIZE MONEY

All prize money won (\$CAD) will be credited to the accounts through the show office.

JOGG HUNTER

In all hunter classes, except miscellaneous hunter classes, horses and ponies must be presented at the trot for the evaluation of their fitness to compete.

Horses and ponies must trot a circle on a loose rein at the end of each over fences performance. At the judge's discretion, a horse or pony may be asked to return to the ring to perform another trot circle.

Any horse or pony deemed unfit to compete will be eliminated and will not be eligible for awards in that class. The judge's decision regarding the fitness of the horse or pony is final.

Trot presentations are not required for miscellaneous divisions.

HORS CONCOURS

As per Equine Canada rules (G201.3) and (G1001.4) no "Hors concours" are allowed in the hunter rings or during equitation/medal classes. The organizing committee reserves the right to accept or refuse any hors concours in the jumper divisions.

COMPETITION NUMBER

The competition number issued by the show office must be always worn and visible anywhere out of the stable at the event location, whether the horse is being hand walked, lunged or ridden. A horse wearing the wrong number may be eliminated.

PRE-SHOW SCHOOLING

On Tuesday, all rings will open from 10 am to 4 pm. All horses must be registered in the pre-show schooling class on www.showmanagementsystem.ca to be allowed to go in the ring. All horses must wear the correct number.

SCHOOLING AREAS

Schooling is permitted in designated areas only, starting at 7:30 am and ending 30 minutes after the last class. Anyone using the rings other than during scheduled time will incur a 50\$ fine. FEI schooling rules will apply.

LUNGING AREA

There will be a designated lunging area on the show ground. Anyone lunging anywhere else on the premises will incur a 50\$ fine. Lunging area close 30min after last class in accordance with A1311.5b.

HUNTER

To participate in a hunter division class, competitors must pay the entry fees for the whole division, unless advised differently in the prize list.

JUMPER

A posted order will be assigned the night before the classes, in the Jumper ring. The posted order will be available online and must be followed by all participants.

Scoring FEI Article 220.2.1.2/ FEI Article 245.3/ Speed FEI Article 220.2.1.1/ All others TBA.

NO SHOW

Officials will tolerate a 3-minute delay and any rider not showing up within that time will be eliminated. This rule will be applied without exceptions.

Coaches are encouraged to get assistance depending on the numbers of riders showing to ensure they do not unnecessarily delay classes.

YOUNG HORSE SERIES : BROMONT EMERGING JUMPERS

This serie is designed to encourage the development of young horses, provide them with positive experiences, and support breeders, owners, and riders.

- NO entry fees to participate in young horse jumper classes (5-6-7 years old)
- NO nomination fee
- A schedule designed to enhance the experience for young horses
- Championship featuring 3 classes during the week
- Efforts are underway to secure one (or more) special sponsors

SHOW FARRIER AND VETERINARIAN

A farrier and a veterinarian will be available on-site every day of competition, all fees must be paid directly to them.

HORSE PATH AND TRAFFIC

All horses must stay in the designated area and horse paths. No horses will be allowed in the vendor area.

STALLIONS

At registration, please notify us by email at cs0@peob.org of the presence of any stallion to help with stall allocation and related planning. Owners must also ensure that the stall is safe for their stallion and, if needed, install stallion partitions one week in advance.

DOGS

All dogs must be on a leash, and their droppings disposed of in the garbage. All offenders will incur a 100\$ fine. We thank you for your co-operation towards a clean and safe environment.

DRUG TESTING

A fee of 8\$ for drug tests will be added to each horse's bill (amount to be remitted to Equestrian Canada). Any horse entered in any class at a competition may, while on the competition grounds, be selected for equine medication control testing while at the event location (A602.5).

RIDER DRUG TESTING

All riders can be tested for use of illegal substance. All riders recognize in registering in the competition that they can be tested. Competitors should refer to Equine Canada rules pertaining anti-doping rules.

HELMETS

Helmets are mandatory and must be worn by anyone mounted on a horse on the show grounds, with safety harness correctly fastened. It is the responsibility of the rider, the parent/guardian or trainer of the junior exhibitor to confirm headgear worn complies with appropriate safety standards, is properly fitted, and in good condition.

NO-SMOKING

It is strictly prohibited to smoke in all and around stabling area, all offenders will incur a 100\$ fine.

GOLF CARTS

Please reserve before July 7, 2026. Carts may not be available after this date.

All carts must be parked in designated areas only and follow designated paths. No parking will be allowed in the vendor area and close to the show office. All carts must be operated by fully licensed drivers. For any infractions, carts will be confiscated without any reimbursements.

MOTORIZED VEHICLES

All vehicles must be parked in designated areas only. No parking will be allowed on the roads or in the barn areas at any time. All infractions are subject to be towed away and will be fined 100\$.

PARKING

No parking will be permitted around the stables and competition areas. Failure to comply will result in the vehicle being towed and a 100\$ fine being issued to the owner.

HORSE TRAILERS

A special area is designated for loading and unloading of horses, space is limited, we ask your cooperation to quickly leave stabling area once all unloaded. Please refer to site map for horse trailers designated parking area. No exceptions will be tolerated. All infractions will be fined 100\$.

RESPONSIBILITY

Neither the Organizing Committee, nor the owners of the site, nor the officials can be held responsible for any damage, injury or loss suffered by participants and spectators.

INSURANCE

Any rider or owner is solely responsible for any damage caused to a third party by himself, his employees, his helpers as well as his horse. It is therefore strongly recommended to any rider or owner to take out civil liability insurance with sufficient coverage for competitions and to maintain this policy in force.

PERSON RESPONSIBLE

As per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility

Do not participate in this EC- sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. Show management reserves the right to refuse entries based on EC rules.

BIOSECURITY

National Bromont endeavours to provide a healthy environment for all participants both human and equine. Through biosecurity proven good practices such as proof of vaccination for entry, our Healthy Horses Only Policy, an Equine Health Attestation, regular stall disinfection, manure removal, the ability to isolate sick horses, access to veterinary care and hospitalization; National Bromont has a venue specific plan in place in the event of illness.

PROVIDING A SAFE SPORT ENVIRONMENT

When registering for EC sanctioned competitions, all athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Domestic and foreign coaches must be in good standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments. Effective 2023, Coach Status is required to engage in coaching activities at EC sanctioned events.

EQUESTRIAN CANADA STATEMENT OF PRINCIPLES – HORSE WELFARE

1. EC requires adherence to humane treatment of horses in all activities under its jurisdiction.
2. All participants shall be bound by the Horse Welfare Code of Conduct.
3. EC is committed to:
 - a. upholding the welfare of the horse, regardless of monetary value, as a primary consideration in all activities;
 - b. requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to maltreatment;
 - c. ensuring that owners, trainers, and exhibitors and their agents exercise appropriate care and responsibility in the handling, treatment, and transportation of their horses, as well as horses placed in their care for any purpose;
 - d. providing for the continuous wellbeing of the horse by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, and safety;
 - e. continuing to support scientific studies on equine health and welfare;
 - f. requiring owners, trainers, and exhibitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competitions; and,
 - g. reviewing, revising, and developing competition rules and regulations that protect the welfare of the horse.

EC SPORT LICENSING 2026

SAFETY, INCLUSIVITY, & EXCELLENCE

Your guide to the latest updates for the competition season in Canada

IMPORTANT CHANGES have been implemented to enhance the safety and inclusivity of equestrian sport. Whether you're an athlete, parent, coach, official, or competition staff, your role is crucial in upholding these standards. Here's what you need to know:

SAFE SPORT TRAINING PREREQUISITE:

- The two free EC Safe Sport training modules must be completed before purchasing a Sport Licence. Check your training status on MyEC by clicking on the ECampus button.

DISCONTINUED TEMPORARY LICENCES AND TEMPORARY HORSE REGISTRATIONS:

- Temporary EC Sport Licences are now discontinued at competitions. All riders, owners, and coaches must possess an EC Sport Licence to participate in events. All horses must have a Horse Recording where level and division require.

AVAILABLE SHOW LEVEL UPGRADES:

- Explore higher-level competitions with temporary upgrades via your MyEC Portal. Note: National Rankings Points are not tabulated for upgraded results.

COACH STATUS REMINDER—2026 SEASON

- Coaches attending EC-Sanctioned competition must hold a valid Licensed Coach Status. Any Coach with Registered Coach Status must purchase a Single Event Upgrade for \$55.00. This purchase can be made through the My EC account.
- Coaches without a valid Licensed Coach Status or Registered Coach Status with Single Event Upgrade Status are not eligible to be represented as a coach at EC-Sanctioned events and may be subject to fines. Please complete your requirements in advance to avoid any fines and delays.

DECLARE YOURSELF A SELF-COACHED ATHLETE

- Athletes without a coach on-site can declare themselves as self-coached by entering their own **EC SPORT LICENSE NUMBER** or enter "self-coached" in the **COACH FIELD** on their registration/entry form.
- Please note: Coaches that **DO NOT ATTEND** the events **SHOULD NOT BE LISTED** on the entry form.
